

Tour Participant Agreement/Terms and Conditions
“2008 Spiritual Journey to Africa” with Joyce Lynn
August 8-22, 2008

RESERVATIONS: The deadline for reservations is **DECEMBER 1, 2007**. No reservations will be accepted after this date. A **\$500** deposit per person will secure your space. A second payment is due by March 1, 2008 and final payment is due by June 1, 2008. (See tour price and payment due dates below).

TOUR PRICE: \$3,975 (Three Thousand Nine Hundred Seventy Five Dollars)

PAYMENT DUE DATES:

December 1, 2007 - \$500 deposit to hold reservation on the tour

March 1, 2008 – second payment of **\$1,500**

June 1, 2008 – final payment of **\$1,975**

RATES: The Tour price is based on rates of exchange and tariffs in effect at the time of publication and is subject to adjustment prior to departure. Changes to the printed itinerary are not anticipated. However, *Africa Spirit Connection* (the “Tour Organizer”) reserves the right to make changes that may become necessary, with or without advance notice. Changes will not result in a refund or any portion of the Tour price. In the event of any change in rates or exchange, tariffs, or itinerary, any additional costs must be paid by the participant before departure or as soon as the change becomes known.

TOUR PRICE INCLUDES: All ground transportation, including airport transfers for the entire tour; all accommodations (12 nights); all meals on the tour (3 meals a day) plus plenty of fresh fruit for snacking; all non-alcoholic beverages, including bottled water; entrance fees to parks, attractions, etc.; laundry (one time); food and beverage tips at all restaurants; and facilitator/local guide fees. All accommodations will be based on double occupancy. Should any participant require a private room, a single supplement will be added to the tour price.

TOUR PRICE DOES NOT INCLUDE: Air transportation to and from South Africa, internal flights; passports, visas, (entrance fee into Zimbabwe is approximately \$30 - exit fee is included in airfare); inoculations (consult Travelers Health or your doctor for recommendations); meals in transit between U.S. gateway airport and arrival in South Africa; additional laundry; excess baggage charges; accident and baggage insurance; any alcoholic beverages, including wine with meals; (**Note:** It is suggested that participants abstain from the use of alcohol during the entire tour in order to maximize your body’s capacity to imbibe the powerful energies that we will be immersed in during the course of the tour); any items or services of a personal nature, or other items including special snacks you would be inclined to purchase in transit; baggage handling at airports; tips to our local guides, Dean Liprini in South Africa and Thokozani Dube in Victoria Falls at the discretion and in the amount deemed appropriate by each participant.

NOTE: Airfare tickets must be purchased separately by each participant. Round-trip airfare from Milwaukee to South Africa and all internal flights will be booked in advance by Tour Organizer through *Custom Travel*, with group discounted airfare rates for all participants. Exact cost of air travel is not yet available for this tour, but is expected to be in the neighborhood of \$2,500. Exact cost will be relayed as soon as it is provided by travel agency. Tickets must be purchased by each participant directly from the travel agency (*Custom Travel*) no later than 45 days prior to departure. Printed itinerary will be provided to each participant by Tour Organizer well in advance along with instructions for payment. If joining the Tour from any location other than Milwaukee, each participant is responsible for booking air travel from your city of origin to and from Washington/Dulles, which is the departure city/airport to South Africa.

FOREIGN EXCHANGE: South Africa's currency is Rand and US dollars can be exchanged at the airport in Johannesburg upon arrival.

PASSPORT AND VISA: Passport must be obtained in advance. If you don't already have one, you should apply NOW. It is the participant's responsibility to ensure current and valid passport. Visas are obtained upon entrance to South Africa (at no cost) and are not required in advance. Entrance fee (visa) into Zimbabwe is approximately \$30 and is paid (in cash) at the airport in Victoria Falls.

CANCELLATION POLICY:

Cancellation between December 1st and March 1st will forfeit entire deposit.
Cancellation after the March 1st payment will forfeit entire deposit plus a 5% penalty of the total cost of the tour for each month thereafter.

NATURE OF THE TOUR:

The Tour is a spiritual pilgrimage to Africa. As such, we will be exposed to powerful energies associated with sacred sites. We will be involved in sacred ceremony, meditation and other spiritual practices throughout the tour. Exposure to these energies has the potential to be a catalyst for a profound shift of consciousness. I will be available to assist and facilitate any difficult energies that you might experience, both individually and within the context of the group process throughout the tour. While our days will be full, there will also be ample time for reflection, journaling and just "being". Finally, in undertaking this kind of adventure, traveling to exotic lands, invariably things don't always go as planned. We must be open to the spontaneity of Spirit, expect the unexpected, and truly "go with the flow". Upon receipt of your deposit, and as the time gets closer, I will e-mail you with more information regarding suggested items to bring, clothes to pack, weather, etc.

RELEASE/WAIVER OF RESPONSIBILITY:

The Tour Organizer (*Joyce Lynn/Africa Spirit Connection*) will have no responsibility or liability for any delays (including delayed departures or arrivals); missed airline or other carrier connections; injury, sickness, loss (including loss of life), or damage to persons or property (including luggage), unless it results from the negligence or willful misconduct of the Tour Organizer; or additional expenses resulting from changes in exchange rates, tariffs, or itinerary. I understand it is my option to obtain travel insurance at my own expense. The Tour Organizer will have no responsibility or liability for any participant who leaves the Tour prior to its conclusion or for any activity undertaken by any participant which is not included on the Tour itinerary.

By signing this Tour Participant Agreement, the participant releases the Tour Organizer from any such responsibility or liability.
